**Highlights of Rental Agreement:**

- I understand that if equipment is not returned within 9 calendar days of the rental term expiration, automatic extensions of 2 weeks at a rate of \$250.00 will be charged to my account (read "Automatic Extension" below for details). \_\_\_\_\_ (Initials)

**PAYMENT:** All rentals are payable in advance, beginning on the effective date of delivery, by credit card. Cash and/or checks will not be accepted.

**EXTENSION OF RENTAL TERM:** Renter may opt to extend the rental term an additional 2 weeks for \$250.00 or 4 weeks for \$450.00. Renter MUST notify either Game Ready Veterinary or their sales rep. to extend the rental term. A separate rental extension order will be placed with the corresponding payment applied. Rental extensions may be verbally requested and confirmed. **AUTOMATIC EXTENSION:** The equipment is due back within 9 calendar days of end of the rental term. An automatic extension of 2 weeks at the rate of \$250.00 will be applied to customer's credit card if the equipment is not returned within the 9 days. The extension will begin the day after the prior rental period expired. Automatic extensions will be applied at two-week intervals until customer returns the equipment to Game Ready. **OPTION TO PURCHASE:** Renter has the option to purchase a system at any time. **If a purchase is completed within 30 days of the end of the rental term, the initial rental fee (not including insurance, shipping charges, or subsequent additional extensions) will be applied as a credit towards the purchase price.** Purchased equipment shall be from new inventory and will include the warranty as defined in the product user manuals, commencing on the date of original delivery. **DAMAGE INSURANCE:** The risk of loss, injury, or destruction of the above equipment from any cause whatsoever, at all times subsequent to the delivery thereof, is hereby assumed by the Renter, and such injury or destruction shall not operate in any manner to release the Renter from the obligation to make the payments aforesaid and renewal or extension in the terms of this agreement. Renter shall maintain equipment in good working order. **A one-time mandatory damage insurance fee of \$50.00 is applied to each rental, which will eliminate charges for damage to the system.** **SHIPPING:** A mandatory flat fee of \$85.00 is charged for shipping costs. All rentals are shipped for overnight delivery to the customer. Rental orders received by 2:00pm PST at the Game Ready offices will be processed for shipment that day. Orders received after 2:00pm PST will be sent the following day. All rentals are shipped with a prepaid return shipping label for the customer to use in returning the equipment. If the return label is misplaced or damaged, a duplicate return label may be obtained from Game Ready at no charge. **TAXES:** Renter agrees to pay all taxes associated with the delivery of the equipment and such sums shall be payable to the Company upon delivery of the equipment to the Renter. If claiming a tax exemption, Renter must provide the Company with a valid tax exemption certificate prior to invoicing. **PROVISIONS AS TO USE:** This agreement is intended by the parties as an agreement to rent and not to sell, conditionally or otherwise. The equipment rented is and shall remain the property of Game Ready, and Renter shall have no right, title, or interest therein. Rental products offered through this program are for Veterinary use only. **DURATION OF AGREEMENT:** This agreement shall remain in force from the date of delivery and initial billing until entire system is returned to Game Ready. The Renter will deliver the above equipment to Game Ready in good condition, except for normal wear and tear. Any pieces of the equipment not returned will be charged to Renter at the then published retail price.
